C. Other Terms and Conditions

- a) Auction/bidding shall be only through "Online Electronic Bidding" through the website https://indianbankseauction.com. Bidders are advised to go through the website for detailed terms before taking part in the e-auction sale proceedings.
- b) Encumbrance details of the propoerty mentioned in the description of the property schedule To the best of knowledge and information of the Authorized Officer. However, the intending bidders should make their own independent inquiries regarding the encumbrance, title of property/ies etc, and to inspect & satisfy themselves. The properties will be sold on 'As is where is', 'As is what is' and 'Whatever there is'. and the sale will be conducted without any responsibility/Liability on the side of the bank for any statutory/Legal liabilities or for the other liabilities or for the delay for the completion of the sale. The auction participants should enquire with Tax/Revenue Authorities and verify themselves regarding the title extent, classification, liabilities, Claims/ rights/dues up on the property.
