Russia to expel six UK diplomats over alleged subversive activities

Starmer, Biden to weigh Ukraine's request to use long-range missiles

WASHINGTON

THE Russian authorities accused six British diplomats of spying and said they would be expelled, as tensions between Moscow and the West grow during an intensified push by Ukraine to loosen restrictions on using weapons provided by the United States and Britain to strike Russia.

Russia's Federal Security Service said in an online statement Friday that a decision was made to withdraw their accreditations, and Russian state television quoted an official from the security service known as the FSB as saying they would be expelled. The move comes as Prime Minister Keir Starmer visits Washington for talks with President Joe Biden that will include Ukraine's request to use Western-supplied weapons against targets inside Russia.

Prime Minister Starmer said on his way to the US that Britain does not "seek any conflict with Russia." "Russia started this conflict. Russia illegally invaded Ukraine. Russia could end this conflict straight away," he told reporters.

"Ukraine has the right to self-defence and we've obviously been absolutely fully supportive of Ukraine's right to self-defense we're providing training capability, as you know. But we don't seek any conflict with Russia that's not our intention in the

The FSB said it received documents indicating that the diplomats were sent to Russia by a division of the UK Foreign Office "whose main task is to inflict a strategic defeat on our country," and that they were involved in "intelligence-gathering and subversive activities.'

Based on these documents and "in response to numerous unfriendly steps by London," the Russian Foreign Ministry withdrew the accreditation of the diplomats, the FSB said, without identifying them. It mediate comment from Britain's Forwarned that if other diplomats are

found to be carrying out "similar actions," the agency "will demand early termination of their missions" to Russia. Russian state TV said in a report that the six diplomats had met with independent media and rights groups that have been declared 'foreign agents' a label the Russian authorities have actively used against organizations and individuals critical of the Kremlin.

The British Embassy in Moscow did not immediately respond to a request for comment. There was no imeign Office.

North Korea releases its nuke enrichment facility's images

SEOUL

NORTH Korea released images of its uranium enrichment facility for the first time on Friday, showing leader Kim Jong Un touring it as he called for more centrifuges to boost his nuclear arsenal. The country, which conducted its first nuclear test in 2006 and is under rafts of UN sanctions for its banned weapons programmes, has never publicly disclosed details of its uranium enrichment facility.

Such facilities produce highly enriched uranium — which is needed to produce nuclear warheads — by spinning the fissile material in centrifuges at high speeds. Kim toured the Nuclear Weapons Institute and the "production base of weapon-grade nuclear materials," the official Korean Central News Agency reported, without giving the location of the facility or the date of the visit.

Kim "stressed the need to further augment the number of centrifuges in order to exponentially increase the nuclear weapons for self-defence," state media reported. AFP

Israeli forces withdraw from West Bank's Tubas



TUBAS

THE families of Palestinians who were killed in an air strike in the occupied West Bank city of Tubas held funerals on Friday after Israeli forces withdrew following their latest raid in the territory.

Violence in the Palestinian territory had already soared alongside the nearly 12-month-old war in Gaza but in late August Israel began large-scale raids that residents say marked an escalation.

A military statement on Friday said Israeli forces had "conducted a 48-hour counter-terrorism operation" in the areas of Tubas, Tamun and Faraa, killing "five armed terrorists" in an air strike and a sixth in "exchanges of fire" with "a terrorist that hurled explosive devices".

Major Israeli operations in the West Bank are sometimes occurring "at a scale not witnessed in the last two decades," the UN human rights chief said.

The four men buried in Tubas on Friday were killed in the air strike, which the Palestine Red Crescent Society said occurred at dawn on Wednes-

Gunmen kill 14 in Afghan Shia area

KABUL

GUNMEN killed 14 people in a Shiamajority area in central Afghanistan, the Taliban said on Friday, in one of the deadliest attacks in the country this year. Six other people were wounded in

the assault. The Islamic State group claimed re-

sponsibility before the Taliban acknowledged the shootings, which took place on Thursday and targeted Hazara Shiite people as they travelled between the provinces of Ghor and Daikundi.

A machine gun was used in the assault, the IS group said. It gave a higher death toll than the Taliban.
