With their glossy green leaves accented by yellow stripes, the neatly arranged fields of Dracaena Fragrans Massangeana have become a defining feature of Kodumon, a village nestled in the lower foothills of the Western

Ghats, these days. It was just a year ago that this ornamental plant, native to tropical Africa, made its way into the oncebarren farmlands of Kodumon. And what began as an experimental venture has now blossomed into a thriving industry, bringing significant returns to the local community.

#### **Maximising earnings**

Tapping into the booming ornamental plant market both within and beyond Kerala, the village has now

national exports to maximise the earnings of its growers.

According to A.N. Salim, chairman of the Kodumon Farmers Producer Company, the initiative took shape last year when the collective decided to cultivate the plant on 11 acres of unused land.

in the panchayat," he explained.

Massangeana plants take around 10 to 12 months to mature, requiring a balance of sunlight and shade for optimal growth. While special fertilizers are not necessary, organic nutrients can enhance its yield. "Once harvested, the leaves are washed, cleaned, and bundled by farmers before being handed over to the company, which then markets them," Salim explains.

### Easy to maintain

The earnings, though seemingly modest, are steady. Each leaf fetches between ₹1 and ₹1.50, depending on quality. A single plant produces a minimum of five new plants annually, and harvesting can begin as early as the eighth month. The plant is also easy to maintain and

stem cuttings, making it a sustainable choice for farmers.

One year on, growers in Kodumon are whelmed with orders, with Bengaluru emerging as a key buyer.

Commenting on the initiative, agriculture officer Renjith Kumar said the panchayat and Krishi Bhavan are working on expanding Massangeana cultivation across the region to further capitalise on market demand. "Buoyed by this success, we are also introducing Heliconia, another ornamental plant, into the panchayat's farming landscape," he said.

Local body president K.K. Sreedharan adds that the administration is fully backing this "flori-village" initiative. "We see this as an opportunity to explore new avenues in organised farming and marketing," he noted.

Speculation is mounting over who will succeed A.V. Russel as the district secretary of the Communist Party of India (Marxist) in Kottayam, who passed away last week.

With the CPI(M) State conference set to begin on March 6 in Kollam, the State secretariat of the party is expected to take up the matter at its weekly meeting on Friday.

The final decision on the new district secretary is likely be announced at the upcoming district committee meeting scheduled for March 1. Party State secretary M.V. Govindan is expected to attend the meeting.

fluence of Minister V.N. Vasavan in the selection process, Mr. Raghunath and Mr. Radhakrishnan, both of whom have close ties with him, are seen as the front-runners. However, Mr. Anilkumar, who maintains strong connections with the State leadership, remains a viable option.

Sources, meanwhile, are also pointing to the possibility of the leader being inducted into the district committee to fill the vacancy left by Russel. Mr. Anilkumar was elected to the State committee during the last party conference despite not being a representative at the event.

Since the next district secretary will serve a term of three to six years, the State leadership is weighing all factors before taking the final call, they added.
