He appears hesitant to sever ties with Trinamool Congress and seems unwilling to join Congress. High-level UDF meeting tasks Satheesan with framing modalities to include Anvar in the front

ncertainty hangs over the entry of former Nilambur legislator P.V. Anvar, who previously won as an Independent candidate backed by the CPI (M)-led Left Democratic Front, into the Opposition Congress-led United Democratic Front (UDF) and its forging of an electoral understanding with him for the upcoming byelection triggered by his resignation.

The Congress leadership wanted Mr. Anvar to either directly join the party or align with a minor constituent of the UDF.

However, he appears hesitant to abruptly sever ties with the Trinamool Congress (TMC) where he holds the post of State con-

Moreover, he also does not want to join the Congress, a move he knows as a former Congress leader,

would not only be politically detrimental but also diminish his bargaining power within the UDF.

Congress suggestion

Considering the strained relations between the Congress and the TMC in West Bengal, the Congress leadership has urged Mr. Anvar to cut his connections with the TMC, suggesting he instead join the Communist Marxist Party (CMP). In fact, Mr. Anvar was to hold discussions with CMP general secretary C.P. John here on Friday, but the meeting did not materialise.

Meanwhile, a high-level UDF meeting convened in Kozhikode on Friday welcomed Mr. Anvar into its fold and decided to entrust the Leader of the Opposition in the Assembly, V.D. Satheesan, with the task of formulating the modalities for his inclusion in the alliance. The final decision about associating with Mr.

Anvar would be taken after consulting with the Congress high command, UDF convener M.M. Hassan said at a press briefing.

Despite this development, speculation is also rife that the TMC national leadership has given approval for Mr. Anvar to contest the byelection, should he fail to reach an agreement with the UDF. Incidentally, Mr. Anvar welcomed the decision of the UDF meeting.

Mr. Anvar, elected from the Nilambur constituency

as an LDF-supported candidate in both 2016 and 2021, shot to limelight following allegations he levelled against Chief Minister Pinarayi Vijayan, his political secretary P. Sasi, and a team of police officers, including Additional Director General of Police M.R. Ajit Kumar, six months ago. However, Congress leaders now believe that his influence has faded and may not secure the electoral gains the party anticipates in the upcoming bypolls.

Even so, Mr. Anvar retains pockets of influence in the constituency and his political moves will be keenly watched in the bypolls, in the upcoming local body elections this year and the Assembly elections in 2026. He established a new political entity, the Democratic Movement of Kerala, which he later merged with the TMC before his resignation from

Pact for Bhoothathankettu project scrapped due to delay, cost hike: KSEB

A decision was taken to scrap the contract with a consortium of Indian and Chinese firms for the electromechanical works of the 24-MW Bhoothathankettu hydel project on account of the "irresponsible non-cooperative" stand of the consortium, according to the Kerala State Electricity Board (KSEB)

Attempts were also made to pressure the power utility into shelling out an additional hefty sum for importing equipment, the KSEB maintains.

In April, the KSEB had issued orders for terminating the contract with Sree Saravana Engineering Bhavani Ltd. (SSEB), Tamil Nadu, and Hunan Zhaoyang Generation Equipment Company Ltd., China, following an inordinate delay in the despatch of the third and final consignment of equipment from China.

Pact in 2015

The KSEB had inked the agreement for the electromechanical works with the consortium for ₹81.80 crore in March 2015. August 2016 was decided as the completion date. While two consignments of electromechanical equipment had arrived from China, the third was delayed.

In August 2024, Hunan

₹81.80-crore contract with a consortium of **Indian and Chinese** firms for works on the hydel project

Equipment Company Ltd. informed the KSEB that the equipment had been sold to another Chinese firm, ChangSha XingYue Electrical and Mechanical Equipment Co. Ltd. This company took the stand that they could import it, but at a price of \$6.5 million (approximately ₹54 crore).

"Realising it as an attempt to deceive the KSEB, the KSEB demanded that steps be taken for completing the import within 90 days, failing which the the contract would be cancelled and the consortium blacklisted," the KSEB said.

'Violation of contract'

Later, Sree Saravana Engineering Bhavani Ltd. informed the KSEB that an additional ₹9.32 crore should be allocated in advance for importing the equipment. The KSEB found this unacceptable as the condition was in violation of the terms of the contract.

"Although the work should have been completed in August 2016, only 86.61% of it has been completed nine years after the deadline," the KSEB noted.



Heavy rain lashes several districts

Several districts experienced heavy thunderstorm with lashing rainfall

on Friday, prompting weather and disaster management agencies to issue weather alerts.

In a 5 p.m. Nowcast update, the India Meteorological Department (IMD) had placed Thiruvananthapuram, Kottayam, Idukki, Ernakulam, Kannur and Kasaragod districts on red alert (extremely heavy rainfall) for three hours (up to 8 p.m. on Friday). The alerts were scaled down to orange (isolated heavy to very heavy rainfall) and yellow (isolated heavy rainfall) in a subsequent 7 p.m.

As per the latest districtlevel updates, rainfall is likely to taper off over the weekend, although Pathanamthitta, Palakkad and Idukki are likely to receive isolated heavy rain on May

So far this summer, Kerala has received 32% excess rainfall over the normal for the March 1-May 2 period. Eleven districts, have reported excess rainfall.
